This training will be held in two sessions, May 5, 2023 at Manaoag NHS, Manaoag, Pangasinan and June 2, 2023 at Juan G. Macaraeg NHS, Binalonan, Pangasinan.
- 2. Participants to this enhancement training are the **first place winners** in the individual and group categories who were carefully chosen during the recently concluded Division Schools Press Conference. Only one coach per winning school shall be allowed to accompany the journalists.
