2. Participants of the said activity shall be the schools' teaching and non-teaching personnel of elementary and secondary schools ages 59 to 64 years old with sound physical condition.
3. The activity aims to enhance the knowledge, attitude and skills of SDO Pangasinan II senior citizens on healthy lifestyle and wellness; understand their roles and responsibilities, learning their rights, privileges and benefits; and to strengthen their physical, mental, psychological and social well-being.
4. All participants shall be given Service Credits or Compensatory Time -Off for their active participation on the said training that falls during long vacation or holidays.
5. A Registration Fee of P 2,200.00 shall be collected each participant to defray expenses on meals/snacks, honoraria of guest lecturers, training supplies and other incidental expenses. Registration fee and travel allowances of participants, facilitators and technical working group TWG shall be chargeable against school fund (Senior Citizens Fund – 1% of the MOOE) subject to the usual accounting rules and regulations.
