1. The Department of Education Region I through the Quality Assurance Division (QAD) shall conduct a post-evaluation and validation on the implementation of the Joint Delivery Voucher Program (JDVP) for Senior High School Technical-Vocational Livelihood (TVL) specializations for participating schools and JDVP-TVL partners.
2. The activity aims to:
 - a. evaluate the implementation of the program.
 - b. assess the performance of the services by JDVP-TVL partners.

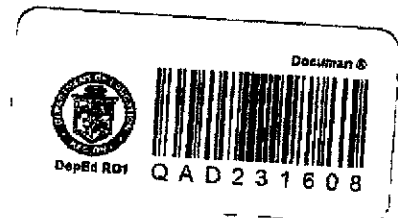


