**DIVISION ALTERNATIVE LEARNING SYSTEM LAC SESSION FOCUSED on  
RPMS-PPST and UNESCO MODULES**

1. The **Alternative Learning System (ALS)** is a parallel learning system in the Philippines that provides opportunities for out-of-school youth and adult (OSYA) learners to develop basic and functional literacy skills, and to access equivalent pathways to complete basic education.
2. The success of the programs, projects and activities is largely dependent on strategic planning and setting of expectations among ALS implementers. One of the in-service training that DepEd is pursuing is the conduct of Learning Action Cell (LAC) Session where it is aimed at creating professional learning communities that will help teachers to have a wider scope of teaching content and methodologies.

In consonance with **DepEd Order No. 35, s. 2016** titled, "The Learning Action Cell as A K TO 12 Basic Education Program School-Based Continuing Professional Development Strategy for the Improvement of Teaching and Learning", a **Division Alternative Learning System LAC Session** will be held on **October 24, 2023 at 8:00 o'clock AM** to be held at **CB Mall, Urdaneta City, Pangasinan**.
3. The following are the objectives of the curricular endeavor;
  - a. Revisit guidelines of the multi-year guidelines on RPMS PPST;
  - b. Orient ALS teachers on the required means of verification to be complied with;
  - c. Acquire proficiency in the preparation of documents and reports relative to RPMS PPST;
  - d. Conduct walkthrough of the UNESCO modules and discuss contextualization/localization in the learning delivery, and;
  - e. Plan for the conduct of 2023 ALS Skills Olympics.
4. The participants for this activity are the ALS teachers, BPOSA representatives and the Education Program Specialists in ALS.
5. In-charge of this engagement is the **Victorious Cluster** under the leadership of **Dr. Jovita I. Padua**, Education Program Specialist in ALS.
