1. **DepEd Order No. 44, s. 2021** titled, "Policy Guidelines on the Provision of Educational Programs and Services for Learners with Disabilities in the K to 12 Basic Education Program" adheres to the process of adaptation where delivery of the curriculum is adjusted through accommodation and modification to ensure responsiveness to the holistic developmental needs of LWDs.
