**ADMINISTRATION OF THE 2023 REGULAR PHILIPPINE EDUCATIONAL
PLACEMENT TEST (PEPT) TO SELECT SCHOOLS**

1. In preparation for the Administration of the 2023 Regular Philippine Educational Placement Test (PEPT), this Office announces the conduct of PEPT registration among interested applicants from **January 31- February 6, 2024**. There are 44 slots allotted to the Schools Division of Pangasinan II hence, registration of applicants shall be on a first come first serve basis.
2. The PEPT is a nationally administered assessment for learners in special circumstances. The result of this assessment will allow these learners to access or resume schooling and/or obtain certification of completion by grade level in the DepEd formal system.
3. The target registrants for PEPT are the following:
 - a. Learners from schools without a government permit
 - b. Learners from nonformal and informal education programs
 - c. Learners who have incomplete or no record of formal schooling
 - d. Learners with back subjects
 - e. Learners who need grade-level standards assessment
 - f. Learners who are overage for their grade level
4. **No test registration fees** shall be collected from the test registrants.
5. The 2023 Regular PEPT Registration Form can be downloaded from **<https://bit.ly/RegPEPTForm>**. Registrants shall submit the following documentary requirements listed below to the Division Testing Coordinator, CID office.

6. **For new applicants:**

- a. Copy of the accomplished PEPT registration form.
- b. Original and photocopy of **Birth Certificate** duly authenticated by the Philippine Statistic Authority (formerly National Statistics Office) or by the Local Civil Registrar.
- c. Original and 1 photocopy of the **permanent school record** (SF 10/Form 137) duly signed by the school principal/registrar/school administrator.
- d. Identical and recently taken 1x1 colored ID pictures with name tag (2pcs).


7. **For test retakers:**

- a. Copy of the accomplished PEPT registration form.
- b. Original and Photocopy of the PEPT certificate of rating (for applicants who need to retake the PEPT subtest).
- c. Identical and recently taken 1x1 colored ID pictures with name tag (2pcs).


8. The placement of the Regular PEPT qualifiers shall take effect in the next of subsequent school year, not during the current school when the test was administered.

9. The list of qualified applicants will be announced in a separate memo.

10. Immediate and wide dissemination of this memorandum is desired.
