1. Pursuant to **Presidential Proclamation No. 1385**, s. 1975, "National Retarded Children's Week Celebration", SDO Pangasinan II through the Curriculum Implementation Division will revive and spearhead the **2024 DIVISION A-B-C CAMP PAG-IBIG** on **February 24 & 25, 2024** at **Mangaldan Integrated School SPED Center**, Mangaldan District II.

All teacher-participants shall be entitled to Two (2) Days' Service Credits as per DepEd Order No. 53, s. 2003 titled, "Updated Guidelines on Grant of Vacation Service Credits to Teachers while the School Head-participants will have Compensatory Overtime Credits (COC) in lieu of overtime pay in accordance with Civil Service Commission and Department of Budget and Management Joint Circular No. 2, s. 2004 - "Non-Monetary Remuneration for Overtime Service Rendered."

6. Travel expenses shall be charged to the downloaded SPED PSF/ MOOE/ Local Funds subject to the usual accounting and auditing rules and regulations.
