    - b. Pagbabaybay – Grade 2
    - c. Muling Pagkukuwento (RFOT Entry) – Grade 3

- d. Pagsulat ng Tula – Grade 4
- e. Talumpati - Grade 5
- f. Interpretatibong Pagbasa (RFOT Entry) – Grade 6

**B. Secondary Level**

- a. Muling Pagkukuwento – Grade 7
  - b. Interpretatibong Pagbasa – Grade 8
  - c. Spoken Poetry – Grade 9
  - d. SULKAS (Sulat Bigkas ng Tula ) – RFOT entry – Grade 10
  - e. Tagisan ng Talino – Grade 11 & 12
5. Travel expenses of the participants to this activity shall be charged against school MOOE or other school/local funds and subject to auditing & accounting rules and procedures.
