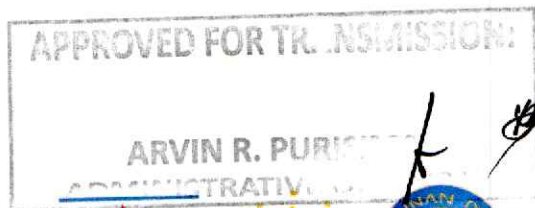

3. It is advised that all TVI applicants submit the required application documents pursuant to DepEd Order No. 006, S. 2023.

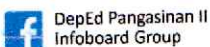
