## NATIONAL IMPLEMENTATION OF LEARNER RIGHTS AND PROTECTION (LRP) ON WHEELS 2024

- 1. Pursuant to the Memorandum issued by the Office of the Undersecretary for Operations OM-OUOPS-2024-05-04956 and Regional Memorandum No. 708, s. 2024, with subject Guidelines on the National Implementation of Learner Rights and Protection (LRP) on Wheels 2024, this Division, shall conduct a caravan titled "LRP on Wheels" on August 14-16, as part of the agency mandate and commitment to ensure the protection and upholding the rights of learners nationwide.
- 2. The activity aims to bring educational rights awareness and protection service to create a safer and more inclusive learning environment for all learners in line with DepEd's zero-tolerance policy for any act of learner abuse, exploitation, violence discrimination, bullying and other forms of abuse, and emphasizes the importance of LRP in schools.
- 3. Hence, all public and private schools are enjoined to put up roll-up banners in the entrance of the school or conspicuous area in the school.   - a. How to Spot the "Red Flags" of Bullying
  - b. Anti-OSAEC and Anti-CSAEM, Safer Internet Practices for Learners
  - c. Empowering Learners to Report Learner Rights and Protection Abuse (LRP) Cases to Learners Helpline and Other Support Services
  - d. Interactive and Panel Discussion
  - e. Art-based activities
  - f. Role-play
- School Heads shall oversee the implementation of these services within their schools. Hence, the Supreme Secondary Learner Government (SSLG) Officer and identified representatives of the mentioned schools will join the said activity.
