# REORGANIZATION OF SCHOOL PARENTS-TEACHERS ASSOCIATION (SPTA) AND SCHOOL GOVERNANCE COUNCIL (SGC)

1. Relative to the implementation of DepEd Order No. 13, s. 2022, re: Omnibus Guidelines on the Regulations of Operations of Parent-Teacher Associations, and DepEd Order No. 26, s.2022 re: Implementing Guidelines on the Establishment of School Governance Council, the following guideline shall be observed:


#### a. For School Parent-Teachers Association (SPTA):


- a.1 All public and private elementary and secondary schools shall organize their Homeroom (HPTA), Grade (GrPTA), and School Parent-Teacher Association (SPTA) not later than August 28, 2024.
- a.2 Schools Heads are advised to review the Omnibus Guidelines on the Regulations of Operations of Parent-Teacher Association to be guided accordingly in the organization of the SPTA.
- a.3 The elected SPTA President of every school (Public and private elementary and secondary) shall convened at the venue identified by the Public Schools District Supervisor/s in coordination of all school heads in the municipality, and elect the Municipal Federated PTA.
- a.4 Election of Municipal Federated PTA shall be conducted simultaneously on August 30, 2024.
- a.5 Reports on the election (minutes and list of officers) shall be prepared and submitted by the Adopt-A-School District Coordinator/s on September 3, 2024 to the division focal person, Mr. Virgilio B. Selga.



# b. For School Governance Council (SGC):

- b.1 The organization of SGC shall be conducted after the SPTA and other internal and internal organizations contributory to the functionality of the SGC has been organized.
- b.2 The School Head shall notify the President of the different groups involve on the organization/reorganization.
- b.3 Schools with existing SGC needing reorganization shall do so by providing a resolution since their term of office is until 2025.
- b.4 The voting members shall be 7-15 members only. Positions to be elected for are Co-chairman (elected) and Secretary.
- b.5 Reports on the organization/reorganization (minutes and list of elected officers) shall be prepared by the SGC designated co-chairman and to be submitted to the office of Social Mobilization and Networking Unit on or before September 3, 2024.
