# ALLOCATION OF FUNDS FOR THE MEAL EXPENSES OF VOLUNTEER TEACHERS AS SUBMITTED BY THE PARTICIPATING SCHOOLS

- 1. Relative to the conduct of the National Learning Camp (NLC) for the SY 2023-2024 as stipulated in DepEd Order (DO) No. 014, s. 2023 titled Policy Guidelines on the implementation of the National Learning Camp (NLC), this office though the Curriculum Implementation Division (CID) provides the breakdown of the actual number of teacher volunteers for the NLC as reported by the school heads/coordinators as of August 14, 2024.
- 2. The provision of funds for the payment of meal expenses for teachers who were involved in the NLC and other End-of-School-Year (EOSY) break activities supporting the National Learning Recovery Program (NLRP) is covered in the Memorandum DM-OUCT-2024-097 dated April 15, 2024.
- 3. The amount of two hundred fifty pesos (Php250.00) per day for DepEd and Non-DepEd teacher volunteers shall be downloaded to the schools listed in this memorandum.
