REITERATION OF DEPED MEMORANDUM No. 152, S. 2011 AND DIVISION MEMORANDUM 349, s. 2022 TITLED: "PREVENTING DENGUE IN SCHOOLS"

- Pursuant to Department of Education Memorandum No. 152, s 2011, which support the Department of Health's (DOH) Campaign Against Dengue, This memorandum is being issued to emphasize the urgency of the Anti-Dengue Drive through the 48 strategy-which stands for Search and destroy, Seek early consultation, Self-protective measures and Say "no" to indiscriminate fogging. It also reiterates and enforce previous memoranda on dengue to protect the school populace from this disease which occur throughout the year and is especially rampant during the rainy season, when aedes aegypti mosquito rapidly proliferate.
- All school heads, teaching and non-teaching personnel including health and nutrition
 personnel are enjoined to conduct information, education campaign, prevention and control
 mechanism to strengthen dengue prevention in schools to continue ensure the health, safety
 and well-being of our learners.
- 3. The following are dengue prevention and control practices recommended by the Department of Health:
 - Search and destroy mosquito breeding sites. Any container that could hold water should be drained or disposed properly, always keep the surroundings clean.
 - Seek early consultation.
 - Self-protection measures like wearing long pants and long-sleeved shirt and daily use of mosquito repellent.
 - Support fogging/ spraying only in hot spot areas where increase in cases is registered for two (2) consecutive weeks to prevent an impending outbreak.
- 4. Furthermore, it is encouraged to report dengue related cases of personnel and learners to our health and nutrition field personnel and local partners (LGUs, Community Health Centers) for proper coordination and recording.




