BKD Elections – President (Advisers)	October 2, 2024 (PM)

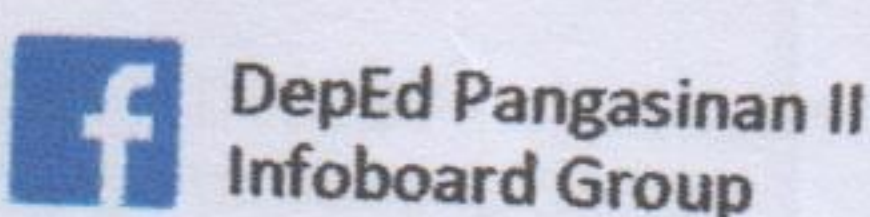
2. The Elections shall be attended by the following:
