CONDUCT OF THE ACCOUNT CREATION AND DATA UPLOADING OF THE WASH IN SCHOOLS (WINS) IN ENHANCED ONLINE MONITORING SYSTEM (E-OMS) INTEGRATE INTO THE LEARNER INFORMATION SYSTEM (LIS)

1. The Department of Education has Issued DepEd Memorandum No. 194, s. 2018, titled "Implementing Guidelines to DepEd Order No. 10, s. 2016 – Policy Guidelines for Comprehensive Water, Sanitation, and Hygiene in Schools Program." This Memorandum is issued to monitor progress, ensure quality, and recognize exemplary performance in WASH (Water, Sanitation, and Hygiene) in schools, facilitating the WINS policy implementation.
2. In this regard, all SDO Pangasinan II Dentists are tasked to monitor and validate WINS programs in their respective Districts and to extend technical support in WINS account creation and uploading of data for School Year 2022-2023 in the Enhanced Online Monitoring System (E-OMS) integrated into the Learner Information System (LIS) WINS Regional Coordinators had extended the deadline twice until March 29, 2024, to allow enough time for the transition to the Enhanced Online Monitoring System (E-OMS)
3. In light of this, the collective efforts of all Dentists have reached uploading and validation of 98.31% (580 out of 590 schools of Pangasinan II). However, the following schools failed to comply due to various reasons despite repeated follow-ups: Baluyot National High School, Mangaldan NHS, San Juan NHS, Cabalitian NHS, Sta. Maria East Integrated School (Secondary), Sta. Cruz Integrated School (Secondary), and Sapinit Elementary School.
4. The WINS Data uploading for School Year 2023-2024 will be from April 08 – May 31, 2024. The Public Schools District Supervisors are requested to monitor this activity in order to comply strictly with the stated duration of uploading.
