**REITERATION ON THE STRICT IMPLEMENTATION OF  
 "NO COLLECTION POLICY"**

1. Pursuant to DepEd Order No. 13 s. 2022, re: Omnibus Regulation on the Operation of Parent-Teachers Association and DepEd Order No. 41 s. 2024, entitled "Reiterating No Collection Policy of Schools", and RA 4206, also known as "An Act Prohibiting the Sale of Tickets and/or the Collection of Contribution for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities", it is hereby reiterated that the approved Voluntary School Contributions (VSC) are only the following:

Philippine Red Cross	P60.00
PTA Membership Dues	Reasonable to be Determined by the SPTA-BOD
Learners Organizations	Based on Existing School Policies
Boy Scouts of the Philippines	Php 50.00
Girl Scouts of the Philippines	Php 50.00
School Publications:	
Elementary	Php 60.00
High School	Php 90.00
Anti-TB Fund Drive	Php 5.00

2. It is emphasized that although the aforementioned contributions are authorized, they remain to be voluntary in nature. **Resolutions and/ or local agreements promulgated either by the school personnel or Parent-Teacher Association which tend to make contributions mandatory are thus declared**

5. **All previous Division issuances which are inconsistent with the provisions of this order are hereby repelled or rescinded accordingly.**
6. Non-compliance to this Division Order is subject to appropriate action. **Public Schools District Supervisors are enjoined to monitor the strict implementation of this order.**
7. Immediate dissemination of and strict compliance with this order is directed.
