 - e. Other relevant matters.

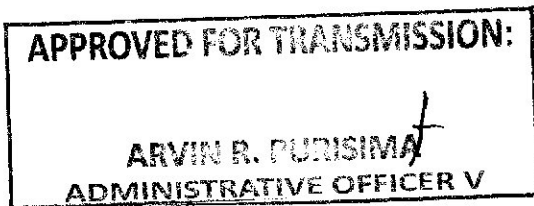






