**CONDUCT OF THE RE-SCHEDULED DIVISION SPORTS MANAGEMENT SEMINAR
FOR TEACHER-COACHES**

1. In line with the division's continuous efforts to enhance the skills and knowledge of coaches in the field of sports, the Schools Division Office of Pangasinan II shall conduct a specialized training seminar titled **Division Sports Management Seminar for Teacher-Coaches**. This training aims to equip teacher-coaches with the latest techniques and strategies to improve athletic performance and overall well-being of student-athletes.
2. The training shall be conducted on these re-scheduled dates, November 7 - 9, 2024 at FEA Bldg., Mangaldan National High School, Mangaldan, Pangasinan. Hence, participants which include; **1 resource speaker, 37 members of the technical working group, and 126 teacher-coaches** or a total of **160 participants** shall be granted with 1 day compensatory time-off (CTO) or service credits subject for the approval of the division and 15 CPD units from the Council of/for Professional Teachers, Professional Regulation Commission.
3. The training shall observe these objectives.
 - a. To apply psychological principles that enhance athletic performance
 - b. To learn the fundamentals of sports biomechanics and the effective use of technology in training
 - c. To develop advanced coaching skills focused on performance improvement and athlete development
4. School heads are requested to ensure the participation of the selected teacher-coaches and members of the technical working group. All involved personnel shall therefore arrange their contingency plans for the first two days of the training to ensure continuity of classes and office functions.
5. This memorandum shall serve as travel authority for all the listed personnel herein attached.
