- 3. The list of presenters, order and guidelines for the defense are attached herewith.



ORAL DEFENSE GUIDELINES

- 1. Each proponent shall render a 15-minute presentation of his/her research proposal
- 2. The content of the presentation shall be the following:
 - a. Context and Rationale
 - b. Action Research Ouestions
 - c. Proposed Innovation, Intervention and Strategy
 - d. Action Research Methods
 - e. Action Research Work Plan and Timelines
 - f. Plans for Dissemination and Utilization
- 3. Proponents are advised to bring three (3) copies of their research proposal.
- 4. Members of the panel are the Assistant Schools Division Superintendents, Chief of the CID/SGOD, Education Program Supervisor in-charge of the Learning Area, Senior Education Program Specialist for Planning and Research and Division Research Coordinators
