**CONDUCT OF ALS PRESENTATION PORTFOLIO ASSESSMENT  
FOR SCHOOL YEAR 2022-2023**

To: Public Schools District Supervisors  
School Heads, Elementary and Secondary

1. The **Department of Education** (DepEd) has established the **Bureau of Alternative Education** (BAE) to ensure effective and efficient implementation of the programs, projects and activities for the Alternative Learning System (ALS).
2. In line with the **Joint Memorandum DM-2022-126**, titled "Presentation Portfolio Assessment (PPA) for Alternative Learning System Accreditation and Equivalency Elementary and Junior High School Learners", the field is hereby informed of the face to face conduct of **PPA Validations for School 2022-2023**.
3. The **District Validation** shall be held on **April 18-28, 2023**, venue of which is at the **District Offices**. Overall supervision is under the care of the Public Schools District Supervisors while validation of the required 10 formal records of each ALS learner is under the responsibility of the School Heads In-charge of ALS.
4. Likewise, PSDSs and SHs in-charge of ALS shall facilitate the Reading and Writing Skills Assessment of ALS Learners. The Reading Tools for Grade 6 Phil- IRI and Grade 8 Phil -IRI shall be used by the ALS Elementary Level and ALS JHS learners, respectively.
5. The designated **District Validators** whose names are found in enclosure no.1 are expected to perform the following functions;
  - ensure that all learners who will join the validation are officially enrolled in the LIS
  - assure the completeness of the submitted Presentation Portfolio Initial Assessment Form
  - assist all ALS learners in complying with required prerequisite forms
  - review / validate the samples of outputs and performance tasks of learners
  - check the eligibility of ALS learners before the Final Assessment
6. The **Division Final Assessment** is set from **May 8- 31, 2023** at the **District Offices** with the Education Program Specialists II-ALS to facilitate the validation using the Presentation Portfolio Assessment Scoring Sheet. The assigned learning strand of the EPSAs and the schedule per district are hereby attached in enclosures no. 1 and 2, respectively.

7. The **Inter-District Revalida** of qualified ALS learners is from **June 5- 30, 2023**. In like manner, the venue is at the **District Offices**. In this phase of validation, the EPSAs together with the Focal Person will administer the Oral Reading Test, Writing Proficiency Test and the Interview to properly ascertain qualification of ALS learners for completion. Only those who met the minimum required points and passed the PPA are eligible to receive the EL or JHS Certificate. The schedule can be accessed in enclosure no. 2.
8. An ALS learner who shall undergo the process of PPA shall be at least 12 years old for EL and at least 16 years old for JHSL during the Inter-District Revalida. Only those who met the minimum required points and passed the PPA are eligible to receive the EL or JHS Certificate.
9. Catch-up plans are in place to accommodate ALS learners who are unable to participate in the above-mentioned phases of validation. Refer to enclosure no. 3 for the dates and venues.
10. Only ALS learners who underwent the District and Final Validations including those who made it through the Catch-Up Plan are allowed to join the Inter-District Revalida.
11. Master List of PPA passers, other required reports and certificates shall be submitted at the **SDO Pangasinan 2 c/o Mrs. Rosie L. Javier, EPSA at CID Office** not later than **July 7, 2023** for the consolidation.
12. All participants in the different phases of in-person PPA validation are required to observe minimum health protocols.
13. Immediate dissemination of this memorandum is highly enjoined.
